<u>Professional Background:</u> My primary career has been as a practicing lawyer, although my interests and pursuits have included a broad range of topics. In 1969, I started as an associate with Arent, Fox, Kintner, Plotkin & Kahn in Washington, D.C. During the Vietnam War I was commissioned as an Army Captain in the JAG Corps and assigned to the Government Appellate Division where I briefed and argued the *Presidio Mutiny* case (a non-violent mutiny anti-war demonstration at The Presidio Army Base) and the *My Lai Massacre* (Lt. William L. Calley) case.

Community Projects & Contributions

- National Legislation on Sexual Assault. The savage murder of LCpl Maria Lauterbach at Camp Lejeune in 2007 and the failure to diligently investigate and prosecute her original sexual assault claim as well as the Marines' disinterest in investigating her one month disappearance ignited the efforts of Mary Lauterbach and me to pursue legislative changes that would improve the protection and rehabilitation of victims of sexual assault, as well as improve the procedures for prosecuting the perpetrators. Mary Lauterbach and I traveled to Washington DC six to eight times to meet with members of Congress and to testify before committees of the U.S. House of Representatives. As a direct result of those efforts, the National Defense Authorization Act in four consecutive years included provisions that addressed sexual assault in the military, including the following changes in the Uniform Code of Military Justice:
 - o Established a right of counsel to victims of sexual assault in the military.
 - o Created "Privileged Communication" protection for Victim Advocates.
 - o Created an accelerated base transfer request procedure for victims.
 - o Significantly increased training and education for sexual assault prevention.
 - O Created an automatic extension of Military Protective Orders ("MPO").
- LCpl Maria Lauterbach, USMC. Beginning with the discovery of the body of LCpl Maria Lauterbach buried in the backyard of fellow Marine Cpl Cesar Laurean on January 11, 2008, I began to represent on a virtual *pro bono* basis, Mary Lauterbach, the mother of Maria Lauterbach. The case attracted the national media, and selecting media opportunities became a critical part of preserving the good name of Maria

Lauterbach. Mary Lauterbach became the voice of her daughter in speaking out for changes for victims of sexual assault in the military and speaking to armed forces throughout the world. From that starting point and continuing through the present I have been working with Mary Lauterbach on these issues, and often speaking and writing directly on these issues. It is particularly rewarding to see the impact that these efforts have had on the military and on Congress in protecting the victims of sexual assault in the military (and increasing prosecutions) a major priority for Congress and the Department of Defense.

Selected by the planning committee of the priests and brothers of the Society of Mary, I conducted the due diligence, created the legal structure, and drafted all documents used to consolidate the four Marianist provinces - the New York Province, the Cincinnati Province, the St. Louis Province, and the Marianist Province of the Pacific - into one national province, the Marianist Province of the United States, effective July 1, 2002.





When Merle Wilberding met writer Tim O'Brien this past November, they realized they had much in common: growing up near the Iowa-Minnesota border; fishing in Iowa's Spirit Lake; attending small Minnesotan colleges; being drafted into the U.S. Army two weeks after graduation.


But their deepest connection is the My Lai massacre. Lying in a ditch in 1969 not far from that Vietnamese village, O'Brien vowed, "I will not stay quiet."

And, "for 40 years he has written and spoken eloquently ... he has used his moral compass to direct his war stories toward the goals of peace," said Wilberding, who as a captain in the Army Judge Advocate General's Corps represented the government in Lt. William Calley's appeal of his court-martial conviction for his actions at My

O'Brien was in Dayton to receive The Richard C. Holbrooke Distinguished Achievement Award; Wilberding serves on the board of the Dayton Literary Peace Prize Foundation which distributes the

Wilberding's service to country and community has also continued since Vietnam pricked the conscience of a nation. This magazine, among many, chronicled his work — with Mary Lauterbach '94 and Congressman Michael Turner '92 — in spotlighting sexual assault in the military and championing legislation to combat it.

Locally, his service (besides the Literary Peace Prize Foundation) includes work with the Dayton Bar Association, Dayton Opera, Greater Dayton Foreign Trade Zone, Montgomery County Legal Resources Board, Muse Machine and the UD School of Law advisory council.

Throughout his career as an attorney in Washington, D.C., and Dayton, Ohio, Merle Wilberding has accrued a lengthy list of prominent legal achievements and worked high-profile national cases. He has repeatedly received the highest ratings from his peers and is continuously named an "Ohio Super Lawyer" and



included in the "Best Lawyers in America." Most significantly, he received the "State of Ohio Award for Distinguished Community Service." He received national recognition as an Army JAG Captain, representing the government in briefing and arguing the appeal in U.S. vs. Lt. William L. Calley, otherwise known as the "My Lai Massacre," a notorious court-martial arising out of the Vietnam War. More recently, in 2008, on a substantially pro bono basis, he represented the family of LCpl. Maria Lauterbach who was murdered in North Carolina. As part of the case, he was interviewed on CNN's morning news, "The Today Show," and other national news shows and testified in hearings before the U.S. Congress. Subsequently, he became a national spokesperson for the victims of sexual assault in the military. 
"These gifts honor Susan's longstanding service and contributions to legal scholarship, and the law review, for

which I have a great deal of respect and admiration," said Wilberding, a 1975 UD MBA graduate, who wrote the law review's first article in 1976.


